#### Opportunity for the Public to Address the Board

Joan Hodawanitz, Scranton: I just want to add to Sandy Longo's comments about the value of libraries in our community, I think everybody is aware of the role that libraries play in supporting literacy among children which is especially important now that we're trying to recover from the effects of the pandemic but there's another aspect I'd like to highlight- this morning and we're all aware of recent events involving gang activity in the County, particularly in Scranton.
